She was member of the Executive Committee and Authorised Management of NBL. She was also Director of Global Funds Management S.A. which is an AIFM management company belonging to NBL.

Virginie is holding mandates as Independent Director on boards and audit / risk committees of banks (from small banks to significant institutions) and she's often chairing the audit committees. She's also the chairwoman of a non-profit organization.
